The academic calendar commences within a week after the admissions are complete. The examinations are conducted by SBTE in May/June and November/December session every year.</p> <p>Two Internal Assessment/ Sessional tests for all theory and practical are conducted and the internal assessment is awarded on the basis of the tests. For appearing in the final examination, the students is required to have more than 75% of the attendance in each subject and minimum 40% marks in the internal assessment tests conducted by the Institution.</p> <p>Tentative Schedule for Internal Tests is:</p> <p>1. Internal /Sessional Test–I after 7 weeks 2. Internal/ Sessional Test–II after 15 weeks</p> <p>The students are required to submit the Examination Form after first Sessional test. Form filling of the Examination Form does not give the right to the students to appear in the Final Examination but students will be allowed to appear in the Final Examination after completing all other requisite formalities of SBTE PATNA. The Roll Number to the students are issued, only after the completion of the semester, and to those students who have 75% of attendance and have passed at least one of the Internal Test. Even if the student appears in the final examination, the papers are cancelled if he/she fails in sessional marks.</p>
