### CLAUSE 1

### CO-OPERATION

**2.4 Placement of trained students:** The second party will actively engage to help the delivery of the training and placement of the students of the first party on the technology trends and in house requirements.

**2.5** There is no financial commitment on the part of the **GOVERNMENT POLYTECHNIC, LAKHISARAI**, the first party to take up any program mention in MoU. If there is any financial consideration, it will be dealt separately.

### CLAUSE 3





### VALIDITY
